NOTICE OF RACE

1. ORGANIZING AUTHORITY:

The Lake Lanier Sailing Club (LLSC) Keelboat Fleet is the organizing authority for this series.

2. Rules:

The Regatta will be governed by the Rules as defined in the Racing Rules of Sailing (RRS) 2017-20, the PHRF Rules and Regulations as adopted and amended by the LLPHRF and the class rules of any one-design fleets as established. The prescriptions of rules 63.2 and 63.4 will not apply.

2 ELIGIBILITY:

The regatta is open to all auxiliary powered keelboats. All boats must have a current LLPHRF rating certificate on file with LLPHRF. <http://www.phrf-lakelanier.com/home/>

3 FLEETS:

Fleets may include: sportboat, PHRF, and cruising. Fleets will be split by PHRF handicap ratings based upon the number of boats registered in the Series. A minimum of four (4) boats will constitute a fleet.

4 SAILING INSTRUCTIONS:

Sailing Instructions (SI's) will be distributed at the LLSC clubhouse during registration each day of the series and will be posted on the official notice board at LLSC.

6. SCORING:

The low point scoring system using the standard time on distance corrected time formula (based on current LLPHRF ratings) will apply to class scoring for each race day. Overall fleet trophies and perpetual trophy will also be awarded to the boat with lowest combined score.

7. COURSES:

Courses will be designated by the race committee before each race using permanent Corps and LLSC marks. Starts will be in the vicinity of X mark.

8. NUMBER OF RACES:

Depending on conditions, more than one race may be started. No races will start after 3:30 pm.

9. TROPHIES:

Trophies will be based on fleet size and will be awarded based on number of registrants and finishers in each fleet after each race day (March 24, June 8, and September 28). The perpetual trophy will be awarded at the end of the series on September 28, 2019.

10. ENTRIES AND FEES:

On-site registration will be available at the LLSC clubhouse on race days at 9:00 am. The entry fee is \$175 for all LLSC Keelboat Fleet events (25 Wed nights, Dogwood and PHRF Championship series) during the year or \$75 for all LLSC weekend Keelboat Fleet events (Dogwood and PHRF Championship series). Registration is available online at www.LLSCKeelboat.com or bring your entry form and payment to the skipper's meeting. Please email stewartdanam@gmail.com if you plan to enter.
